(vi) **Institutional set-up for liquidity risk management**

The Company's ALCO monitors asset liability mismatches to ensure that there are no imbalances or excessive concentrations on either side of the balance sheet. The Company assess and monitor its liquidity risk by estimating the future inflows and outflows during the start of the year and planned accordingly the funding requirement. The Company continuously manages its liquidity by unutilized cash credit facility, term loans, debentures and direct assignment. The composition of the Company's liability mix ensures healthy asset liability maturity pattern and well diverse resource mix. As on 30 June 2023, the Company had liquidity buffer of around ₹ 728.37 Cr. and unutilized Cash Credit facility of around ₹ 375.50 Cr. In addition, the Company has sanction on hand to the tune of ₹ 786.45 Cr. in the form of term loan, direct assignment and co-lending.

The LCR of the Company for the quarter ended 30 June 2023 is 550.23%
